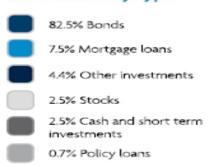

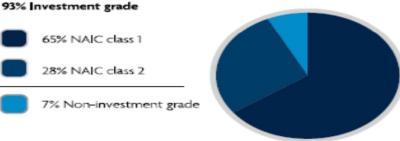




Cost in Average Total Fees Over 30 Years by Brokerage Company


